Privacy and Cookie Policy

Privacy Policy

This Privacy Policy governs the manner in which the Golden Guensey Goat Society ("GGGS") collects, uses, maintains and discloses information collected from Users (each, a "User") of the www.goldenguernseygoat.org.uk website ("Site"). This privacy policy applies to the Site and all products and services offered by the GGGS.

Personal identification information

We may collect personal identification information from Users in a variety of ways, including, but not limited to, when Users visit our site, register to become a member on the site, and in connection with other activities, services, features or resources we make available on our Site. Users may be asked for, as appropriate, name, email address, mailing address, phone number. Users may, however, visit our Site anonymously. We will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply personal identification information, except that it may prevent them from engaging in certain Site related activities.

If we have reason to believe that we hold data personal data for persons under the age of 12 we will delete the data unless we have parental consent.

Non-personal identification information

We may collect non-personal identification information about Users whenever they interact with our Site. Web browser cookies

How we protect your information

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on our Site.

Sharing your personal information

We do not sell, trade, or rent Users personal identification information to others.

Third party websites
